#### **ILC 2025 Leadership Program Payment Information**

Registration for the ILC 2025 LAMP Gold Coast will entitle the purchaser to attend the ILC 2025 LAMP on Day One, Day Two & Day Three, 13-15 October 2025 LIVE (Broadbeach, Gold Coast, QLD, Australia).

#### **2025 ILC Annual International Leadership and Mentoring Program Taxation/GST**

The 2025 Annual International Leadership Program ticket price will be subject to the application of the Australian Goods and Services (GST) Tax for Australian Members only.

#### **2025 ILC Annual International Leadership Program Inclusions/Exclusions: Gold Coast**

##### *Registration for the live ILC 2025 Leadership Program*

The Gold Coast event **does** include:

- access to all the ILC LAMP sessions
- morning tea, afternoon tea and lunch on day one and two, morning tea only on day three
- Access to assessment and mapping tools
- Access to pre-readings and the LAMP Toolkit

The Gold Coast event **does not** include:

- flights, accommodation, transfers, travel and health insurance, breakfast, dinner, or personally incurred incidentals.

## **Payment for the 2025 ILC LAMP Gold Coast Tickets**

### **One-off payment:**

- The one-off payment of the 2025 ILC Annual International LAMP Ticket will be payable in full on selection of the ticket type and proceeding to the ILC Cart/Checkout.
- Payment types accepted: Visa and Mastercard  
The ILC can provide an invoice on request, and subject to supply of required details for invoice creation
- All payments must be finalised prior to 30 September 2025

The purchaser is responsible for ensuring they purchase the correct ticket type depending on their membership status with the ILC. You must be an employee of one of the ILC's Founding Partners to purchase a Founding Partner ticket.

## **Refund or Cancellation of 2025 ILC Annual International Leadership Program Tickets**

Cancellation of attendance and refund of the Ticket (type) purchased may be obtained by providing written notice to the ILC Support Team before 15 September, 2025. Cancellation after 15<sup>th</sup> September and up to 30<sup>th</sup> September will incur a charge to cover catering and other related costs of up to 50%.

### **ILC 2025 LAMP Registration: Gold Coast**

Up to 11.59pm (Australian time), 15 September 2025: 100% refund

Up to 11.59pm (Australian time), 30 September: 50% refund.

No refunds will be provided for cancellation after 30 September except under exceptional circumstances, at the discretion of the ILC Inc Management Committee.

The ILC reserves the right to cancel the Leadership & Mentoring Program if not enough tickets are sold by 15 September 2025. In this case, the ILC will refund the price of the ticket to the purchaser. The ILC is not liable for recovery of the cost of any money lost due to travel or accommodation.
