### **ILC 2026 Annual International Conference Payment Information**

This payment information applies to the International Learning Collaborative (ILC) 2026 Annual International Conference in Oxford, UK.

Registration for the ILC 2026 Annual International Conference will entitle the purchaser to attend the ILC 2026 Annual International Conference on Day One and Day Two, 13 & 14 June 2026 LIVE (Oxford) or Virtually (dependent on type of ticket purchased).

### **2026 ILC Annual International Conference Taxation/GST**

The 2026 Annual International Conference ticket price has GST applicable for Australian Members only.

### **2026 ILC Annual International Conference Inclusions/Exclusions: Oxford**

Registration for the live ILC 2026 Conference

The UK event does include:

- access to all sessions of the ILC Conference in Oxford, UK on 13 & 14 June
- morning tea, afternoon tea and lunch on both days (dietary requirements are accommodated)

The UK event does not include:

- flights, accommodation, transfers, travel and health insurance, breakfast or dinner, or incidentals.

### **Payment of the 2026 ILC Annual International Conference Tickets**

One-off payment:

The one-off payment of the 2026 ILC Annual International Conference Tickets will be payable in full on selection of the ticket type and proceeding to the ILC Cart/Checkout or via invoice.

- Payment types accepted: Visa and Mastercard
- The ILC can provide an invoice on request, and subject to supply of required details for invoice creation
- All payments must be finalised within 14 days of purchase

The purchaser is responsible for ensuring they purchase the correct ticket type depending on their membership status with the ILC.

### **Refund or Cancellation of 2026 ILC Annual International Conference Tickets**

Cancellation of attendance and refund of the Ticket (type) purchased can be obtained by providing written notice to the ILC Support Team before 18 May 2026.

- ILC 2026 Conference Registration: UK  
Up to 11.59pm (Australian time), 18 May 2026: 100% refund Up to 11.59pm (Australian time), 1 June 2026: 50% refund
- ILC 2025 Conference Registration: Virtual  
Up to 11.59pm (Australian time), 2 June 2026: 100% refund

The ILC will cancel your ticket purchase if you do not pay your ticket order 14 days after requesting an invoice.

Tickets for in-person attendance ILC 2026 Conference are limited. Please note, should there be simultaneous ticket sales or website technical issues, the ILC may cancel your ticket purchase for ILC 2026 Conference. If online tickets sales exceed three hundred (300) participants. Tickets will be awarded based on 'time and date of purchase' as recorded by the ILC's payment gateway in this instance.

Should the ILC need to cancel, reschedule, or postpone the conference, Ticket Holders will be contacted and can either re-schedule their attendance to virtual (providing a partial refund) or request a full refund (based on date of purchase).

### **Virtual Conference**

The ILC will provide an online Conference over two (2) days. Attendees are not able to share login, QR Codes, or links with non-paying attendees.
