### ILC 2022 Annual International Conference Payment Information

This payment information applies to the International Learning Collaborative (ILC) 2022 Annual International Conference.

Registration for the ILC 2022 Annual International Conference will entitle the purchaser to attend the ILC 2022 Annual International Conference on Day One and Day Two, 13 and 14 June 2022 LIVE (Oxford) or Virtually (dependent on type of ticket purchased).

### 2022 ILC Annual International Conference Inclusions/Exclusions: Oxford

The Oxford event **does** include:

Up to 11.59pm (Australian time), 6 June 2022: 100% refund

The ILC will cancel your ticket purchase if you do not pay your ticket order prior to 12 June 2022.

Tickets for ILC 2022 Conference Registration in person attendance at Oxford are limited. Please note, should there be simultaneous ticket sales or website technical issues, the ILC may cancel your ticket purchase for ILC 2022 Conference Registration: Oxford if online tickets sales exceed sixty (60) participants. Tickets will be awarded based on 'time and date of purchase' as recorded by the ILC's payment gateway in this instance.

Should the ILC need to cancel, reschedule, or postpone the conference, Ticket Holders will be contacted and can either re-schedule their attendance to virtual (providing a partial refund) or request a full refund (based on date of purchase).
